

Variance Analysis



Report Summary

This report is designed to display specific revenue and expense related line items as per the audited financial statements for all unrestricted funds by Organization Code, regardless of organization level. Separate columns appear for **Current Fiscal Year** (*Operating/Non-Operating*), **Prior Fiscal Year** (*Operating/Non-Operating*) and **Variance** (Current vs. Prior). Multiple drilldowns allow for various levels of detail information. All line items with a variance of +/- \$100,000 appears in **red typeface**.

Current Fiscal Year totals and Prior Fiscal Year totals are displayed. Both are broken down by Operating and Non-Operating. Variance information is provided by dollar value and by percentage change.

Note:

The data warehouse includes all transactions up to and including yesterday's data. Changes made in the Finance system today will only appear in the data warehouse tomorrow.

Current and Prior Fiscal Year Total (Operating + Self Financing) – Sum of actuals regardless of fund type code

Variance in Dollars – Current Year totals minus Prior Year totals.

Variance in Percent – % change Current versus Prior Year.
