INTERN'S DUTIES AND RESPONSIBILITIES:	<ul style="list-style-type: none"> - Specific task assigned by the Deputy Director/Head of Research and Programs. - Develop project proposals/concept notes; conduct desk research; and write research reports is an added advantage. <p>Currently, the Center has a number of on-going research and programs activities which are grouped under seven broad thematic areas, namely, Afrobarometer Survey; Local Government Decentralization; Elections Credibility Enhancement; Human Rights Promotion Constitutional Development; Environmental/Natural Resource Governance; and Governmental Transparency and Accountability.</p> <p><i>Interns' duties and projects may not be as listed. These will depend on the needs of the host organization.</i></p>

COSTS:	The intern is responsible for all costs associated with the internship including transportation, accommodations, etc.
TRAVEL ARRANGEMENTS:	Preparing travel arrangements to and from the internship host organization is the responsibility of the intern.

It is up to the student to fully assess and prepare for any health or security risks that may be involved in pursuing this internship. Applicants are encouraged to discuss potential risks with their family prior to applying.</p> <p>Applicants must ensure that they are physically and mentally capable of successfully completing an internship in the internship host country. The Arts Internship Office may request a doctor's attestation that an applicant is sufficiently healthy to complete an internship.</p>
ENTRY REQUIREMENTS:	<p>Interns are responsible for informing themselves of what entry requirements are required to visit and work as an intern in the internship host country. These may include a visa, work permit, passport valid for at least 6 months after entry, and proof of certain vaccinations.</p> <p><u>The intern is responsible for acquiring all necessary documents in time for the beginning of their internship.</u></p>
