DESCRIPTION OF HOST ORGANIZATION:	The Conference Board of Canada is recognized worldwide for its expertise in economic forecasting, modelling and analysis. The Forecasting and Analysis group provides quarterly national, provincial and metropolitan economic forecasts to help our customers understand and anticipate the short and long-term trends in the domestic economic environment
INTERN'S DUTIES AND RESPONSIBILITIES:	 Conduct quantitative research and related activities, in topics such as economic forecasting, economic impact analysis, benchmarking, and policy analysis. Conduct literature reviews. Collect, review, and analyze data. Gather data and build databases. Produce charts and tables. Assist in preparing written reports, articles, commentaries and blogs, and Power Point presentations. Actively contribute and participate in a dynamic and highly productive team environment.
HOST ORGANIZATION'S REQUIREMENTS:	 Enrolled in an economics degree program or/and pursuing a Master's degree in Economics. Has an interest in gaining experience and exposure into a career in economic analysis and forecasting. Ability to discuss and apply economic principles and theory. Highly organized with project management skills (i.e.: establishing goals, priorities, and deadlines and delivering on expected outcomes). Well-developed analytical as well as oral and written communication skills. Some experience/exposure to EViews would be an asset.

ELIGIBILITY:	 McGill Faculty of Arts student (completed 60 credits) Minimum CGPA of 2.7 Returning to McGill in the fall semester following the internship Students must fulfill Faculty of Arts requirements as outlined in the Handbook for Interns https://www.mcgill.ca/arts-internships/resources
COSTS:	The intern is responsible for all costs associated with the internship including transportation, accommodations, etc.

TRAVEL	Preparing travel arrangements to and from the internship host organization is the

ACCOMMODATION:	Finding suitable lodging during the internship is the responsibility of the intern.

ENTRY	Interns are responsible for informing themselves of what entry requirements are
REQUIREMENTS:	required to visit and work as an intern in the internship host country. These may include
	a visa, work permit, passport valid for at least 6 months after entry, and proof of certain
	vaccinations.
	The intern is responsible for acquiring all necessary documents in time for the beginning
	of their internship.
