# FACULTY OF ARTS Minutes of Meeting March 10, 2015 Robert Vogel Council Room

#### Order

Associate Dean Engle-Warnick welcomed Provost Masi to the meeting and conveyed the regrets of Dean Manfredi. Associate Dean Engle-Warnick called the meeting to order at 3:05 p.m.

The first piece of business was to give speaking rights to colleagues attending the meeting from the Faculty of Religious Studies as well as to the Arts administrative and support staff present.

Mr. Sobat **moved** approval to allow speaking rights to both groups, seconded by Mr. Greenspon. **Carried.** 

#### Presentation - Provost A. Masi

- 401.1 Provost Masi began by thanking the assembly for the opportunity to come and address some of the issues now facing the University. The Provost began by providing a brief overview of the current budgetary situation from the government noting, among other points, that there will be an increase in tuition fees for all Quebec students, that there will be an increase in fees for international students but only for those in deregulated programs for the incoming cohorts, and that the government will continue to study the way in which it finances universities.
- 401.2 The Provost displayed slides that covered topics such as:
  - Key achievements in Arts: very impressive to see the progress in Arts over the last year or so with increases in per-capita Tri-Council funding; per-capita FQRSC funding; research funding; philanthropic support; promoting socially-engaged research and teaching; and finally, reduced accumulated deficit by 29.3% in FY14.
  - Key challenges: deferred maintenance needs; assessment of the success of the
    administrative reorganization; uneven and overall enrolment pressures; courses and
    teaching programs under revision; and the distinctiveness of the McGill B.A. and
    associated pathways to it.
  - Key achievements in Religious Studies: the first Patrick and Barbara Keenan Chair in Interfaith Studies attracted Professor Armando Salvatore to McGill; another Keenan gift supports two Winfred Cantwell Smith Graduate Awards; there is a partnership with the Tony Blair Faith Foundation; the Centre for Research and Education on Religion (CREOR continues to thrive.
  - Key challenges for Religious Studies: the largest challenge is the combination of scholarship and vocational training in religion; limitations on graduate funding;

- recruitment at postgraduate and faculty levels; and an increase in accumulated operating deficit.
- McGill's three strategic priorities: being academically successful; maintaining a student-centred focus; and to manage the resources that is available, this is difficult to do because the Quebec government has launched a series of budget cuts that are truly affecting the nature of higher education in the province.
- ASAP progress report: because the Provost at McGill is also the Chief Academic
  Officer and the Chief Budget Officer the result is that there is a solid alignment
  between its academic goals and its budget process; Faculty-level "Agreements"
  guide resource allocation decisions; performance indicators are being used to track
  progress against established targets.
- Administrative and Support Units: the government imposes cuts on the
  administrative and support staff category which means that the entirety of the cut
  devolves onto the operating budget. This has major implications on how we can
  provide services to students in departments and faculties at the university level. As
  a result, we must think carefully about the existing support levels and how they are
  being supported and where they are located.
- McGill budget context FY2015: a planned deficit of approximately \$7 million is predicted and with unanticipated mid-year reductions to government grant and measures taken in previous years and with careful management McGill should be in a "relatively solid" position by the end of FY2015.
- FY2016 and beyond: preparing for more leaner years: operating revenues in the coming years are now likely to be significantly less than projections contained in the Budget Book for FY2015.
- Looking ahead for FY2016-FY2019: revenues and expenses.
- Looking ahead for FY2016-FY2019: goals
- Looking ahead for FY2016: commitments to the McGill community and institutional commitments (deferred maintenance and infrastructure needs).
- FY2016 and beyond: revenue growth and diversification How can we grow our existing sources of revenues? What mechanisms are available to allow us to generate new revenue sources?
- McGill Innovative Learning Environments (MILE): transforming teaching and learning

   reimagining the Library; teaching Innovations Complex (TIC); infrastructure and
   information technology upgrades; innovative partnerships (MOOCs within the edX
   Consortium and elsewhere).
- Principal's priorities: an open, connected, and purposeful McGill three priorities: student life and learning, research, and community engagement; two priorities that support the mission – our work culture and transformations (physical and virtual campus).
- (Some) Current Projects in the Office of the Provost: period of transition Professor
  C. Manfredi becomes Provost July 1; searches for new Deans; FBI/FBM; copyright
  compliance; edX consortium (MOOCs and SPOCs); academic planning for future of
  the RVH and the Neuro; fundraising for priority initiatives; composition of
  Senate/structure of Senate meeting committee; updating McGill's course evaluation
  policy; and U15 and AAU data exchanges.

- 401.3 After a question and answer period that covered important topics such as budget issues, Library issues, target enrolment for Arts, old IT equipment, etc., Provost Masi concluded his presentation.
- 401.4 Associate Dean Engle-Warnick thanked the Provost for providing such an interesting presentation. Faculty applauded.

402.1 Professor Meadwell **moved** approval of the agenda, seconded by Professor Johnson. The Associate Dean asked that Item 9(f) be moved to Item 2 so that Professor Jouve-Martin could present his annual report before leaving to teach his class. **Carried, as amended.**
