CIRCUMSTANCES AFFECTING PRODUCTIVITY

From September 2003 to June 2011, I was Assistant then Associate Professor at School of Business, Public Administration, and Information Sciences, Long Island University (LIU), Brooklyn Campus, N.Y., U.S. This was a teaching intensive institution where I taught 18 credits per academic year (6 full courses). This did not affect my research productivity in terms of journal publications and conference presentations at first. However, the teaching load started to affect my research productivity once I became pregnant and had twins in 2009. LIU did not offer me a maternity leave.

Also, the School of Business, Public Administration, and Information Sciences did not grant PhDs, so I was only able to start supervising PhD students after I joined the Desautels Faculty of Management McGill University.

Finally, the School of Business, Public Administration, and Information Sciences did not have a culture of grant funding. I thus only started applying to and getting research grants after I joined the Desautels Faculty of Management of McGill University.
