- Quality assurance, management and analysis of performance management and evaluation data;
- Developing and implementing performance management reports, scorecards, dashboards and other tools;
- Developing and conducting surveys for PME and other departments and communicating results that meet both internal and external stakeholder needs; and
- Developing and delivering capacity building activities such as consulting, mentoring, educating and training to internal and external stakeholders.

- At least seven years progressive experience in the research and innovation environment in the
 practical application of advanced evaluation methodology, survey design, scorecard
 development, advanced statistical analysis and report writing (both technical and nontechnical);
- Relevant experience in survey design, implementation and data analysis.
- Demonstrated experience in implementing rigorous evaluation design; collecting, managing and analyzing data; reporting and optimizing the use of results with diverse stakeholders; and conducting quality assurance initiatives; and
