### **In-house Teaching Materials, etc:**

The textbook for Immigration and Refugee Law is badly out of date, and there is no other commercially available. I had to supplement almost every lecture with new cases and commentary on statutory reforms, all of which I made available to students via myCourses.

N.B.: I spent most of my research time in 2012 and 2013 working on a SSHRC-funded book project, "International Law and the Fiduciary Constitution of Sovereignty" (with Evan Criddle). These efforts culminated in a book contract with OUP in early 2014, with a contract date for final submission of October 15, 2014. This in part explains my less-than-usual research productivity in 2013. The remainder of the explanation has to do with the peculiarities of academic publishing: two pieces appeared in 2012 that normally would not have come out until 2013, and a further piece that should have come out in 2013 won't appear until later this year (2014). My rule-of-thumb goal is to write 4-5 major pieces a year, or their equivalent (e.g., chapters for a monograph).
