#### **Preface**

The present document is the third in a series of discussion papers prepared by the Executive of the MAUT Librarians' Section on the subject of governance-related committees. The first paper presented some opening considerations and provided a list of committees. The second paper outlined some questions to be considered regarding how governance-related committees should be established and filled. The third paper presents some sample materials on nomination and election processes. Additional discussion papers, potentially including recommendations from the MAUT-LS Executive, may be prepared thereafter.

Trenholme Dean of Libraries LIBRARIAN REPRESENTATIVES ON SENATE

The Deans have been notified that we need to hold elections for University Senators whose terms are concluding.

Nominations are invited for two librarians to serve three-year terms as librarian representatives on Senate, replacing Joan Hobbins and Marc Richard, whose terms are concluding 31 August 2012. Article 6.1.1 of the University Statutes states, in part, that librarian members elected to Senate shall be elected for a term of three years, shall be eligible for reelection and shall be from an electorate composed of all librarians performing the function of librarian in the University's library system. Senate membership should represent a wide cross-section of the University community. Senate members need not be tenured. Each librarian should consider seriously the contribution he/she might make and also consider seriously others within the Library who would make valued contributions. The elected librarians will serve terms from September 1, 2012 to August 31, 2015. It is possible to self nominate.

C. Colleen Cook (ex-officio)
Daniel Boyer- September 1, 2011 to August 31, 2014

#### **Nomination and Election Process**

All nominations must be in writing, signed by the nominee, and carry the signature of two librarians who are proposing the nomination. Nominees are requested to submit a short biographical sketch, (3 or 4 lines) which will be sent with the ballot. Nominations should be submitted to Bruna Ceccolini, Office of the Dean of Libraries, no later than 5:00 p.m., Tuesday, April 10, 2012. A list of librarians eligible for nomination is attached.

If only two nominations are received, the nominees will be appointed by acclamation. If more than two nominations are received, an election will be held to elect the two librarian representatives on Senate from the list of candidates who have accepted nomination. Continuing Senator Daniel Boyer and Bruna Ceccolini will count ballots for both the nomination process and subsequent election. Each librarian will vote by secret ballot from 13 April 2012 to 27 April 2012. If no candidate receives more than 50% of the ballots cast, a run-off election will be held to elect the two representatives from the three candidates having received the greatest number of votes in the first round of voting. If only one candidate receives more than 50% of the ballots cast in the first round of voting, that candidate shall be declared elected and a run-off election will be held to elect the other representative from the two candidates having received the next greatest number of votes. The run-off election, if it is required, will be conducted from 30 April 2012 to 14 May 2012.

Dear Colleagues,

The voting period for the election of two librarian representatives on Senate closed on Friday, April 27. The vote count which was originally planned for today has been postponed until Wednesday, May 2, since Daniel Boyer is currently away from the University. He will return on May 2, at which time he and Bruna Ceccolini will count the ballots.

If the vote count shows that no candidate has received more than 50% of the ballots cast, a runoff election will be held to elect the two representatives from the three candidates having received the greatest number of votes in the first round of voting. If only one candidate has received more than 50% of the ballots cast in the first round of voting, that candidate shall be declared elected and a run-off election will be held to elect the other representative from the two candidates having received the next greatest number of votes. The run-off election (if needed) was originally scheduled to last from 30 April 2012 to 14 May 2012. Because of the delay in conducting the vote count for the first round of balloting, the run-off election, if it is required, will begin on (or soon after) 2 May, 2012. The voting period will last for two weeks.

<u>Call for Nominations for the Position of</u> <u>Secretary of the Library Council for 2011-2012</u>

June 20, 2011

Colleagues,

As was discussed at the Library Council meeting of June 14, 2011, one of the new Council's tasks will be to designate a Secretary. This step is required by article 2.4 of the Council's terms of reference, which states:

2.4 The Library Council shall appoint a Secretary of Council.

A Library Council Nominating Committee has therefore been established by Dean Cook, with the nomination process for the Secretary of Council as its first order of business. The members of the Nominating Committee are Marc Richard and Ann Marie Holland.

Nominations are hereby invited for one person to serve as Secretary of Council for a term of one year. All members of the Library Council are eligible to serve as Secretary. Council membership is defined by article 2.1 of the Council's terms of reference, which states:

2.1 The Library Council shall consist of the Trenholme Dean or Director of Libraries, all persons holding an appointment as a member of the librarian academic staff in the McGill University Libraries, and those persons holding an appointment as Curator, Head of Special Collections, Archivist and Head of Digital Initiatives in the McGill University Libraries.

As is indicated by article 3.1 (e) of the terms of reference, Council is responsible for developing and adopting the rules and regulations that will govern its proceedings. This development process will include defining the duties of the Secretary, since these are not specified by the terms of reference. It is anticipated, however, that the Secretary would be responsible for various tasks connected with each Council meeting, such as: a) receiving proposals for agenda items; b) preparing the draft agenda; c) notifying Council members of the date, time and location of the next meeting; d) recording the results of such votes as may be taken; and e) preparing the draft minutes.

#### **Nomination Process**

Nominations for the position of Secretary of Council may be submitted by any member of the Library Council. Self-nominations are permitted. To submit a nomination, please send an email (using your McGill account) to <u>both</u> members of the Library Council Nominating Committee (marc.richard@mcgill.ca and ann.holland@mcgill.ca) giving the name of the person or persons you are nominating. Nominations must be received no later than than 5:00 p.m., July 6, 2011. The members of the Library Council Nominating Committee will be responsible for contacting the nominees to ask if they accept nomination.

#### **Election Process**

If only one nomination is received, the nominee will be appointed by acclamation. If more than one nomination is received, an election will be held to elect the Secretary of Council from the list of candidates who have accepted nomination. Each member of Council will vote by secret ballot from July 7 to July 21, 2011. If no candidate receives more than 50% of the ballots cast, a run-off election will be held to elect the Secretary of Council from the two candidates having received the greatest number of votes. This run-off election, if it is required, will be conducted from July 22 to August 1.

We encourage you to consider serving as Secretary of Council, or to nominate a colleague to serve in this important capacity.

Professor Heather Munroe-Blum's second term as Principal and Vice-Chancellor will end on June 30, 2013. As stipulated in the Statutes of McGill University (Article 1.3.4.1), a Committee to advise the Board of Governors on the appointment of the Principal and Vice-Chancellor, chaired by Mr. Stuart (Kip) Cobbett, Chair of the Board, will have the following composition:

- 2 members appointed by the Board of Governors
- 2 members appointed by the Senate
- 1 member appointed by the Students' Society of McGill University
- 1 member appointed by the Post-Graduate Students' Society of McGill University
- 2 members appointed by the Council of the McGill Association of University Teachers
- 2 members appointed by the Board of Directors of the Alumni Association
- 2 members elected by the Administrative and Support Staff

The Senate Nominating Committee has recommended that the Senate representatives be chosen by election (rather than from names proposed by the Nominating Committee), in a manner consistent with recent past-practice.

Nominations are now called from members of Senate for two representatives and two alternates. Alternates shall serve only in the event that the designated members are unable to serve, in which case they shall be permanent replacements. Representatives of Senate need not be Senators. Any member of Senate may nominate an individual or endorse a nomination. Nominations require the endorsement of two Senators and the consent of the person being nominated. No Senator may nominate more than one candidate. Nominees shall submit a statement of 100-words (maximum) on why they wish to be elected. This statement, together with the nomination form, must be submitted by the deadline indicated below. This statement should also be submitted electronically to pauline.frixione@mcgill.ca.

The official nomination form is attached and may be printed or photocopied as needed. Nominations on other than this official form will not be accepted. Nomination forms must be completed in full.

Nominations are to be submitted to Ms. Pauline Frixione, Chief Returning Officer, Secretariat by 12:00 noon on March 21, 2012. An election by electronic ballot will follow the close of nominations.

Dear Colleagues,

Now that the amendments to the MAUT-LS Bylaw are approved, we need to have an election for the membership of the MAUT-LS Professional Issues Committee (PIC). This email serves as a call for the nomination of members to fill the seven elected-seat vacancies on the Professional Issues Committee.

The amended Bylaw states:

"PIC shall consist of up to seven elected members, one of whom serves as Chair of PIC, plus one ex-officio member appointed each year by the MAUT-LS Executive from amongst the members of the Executive. Any current dues-paying member of MAUT-LS is eligible to be nominated for service as one of the elected members of PIC. [...] The elected members of PIC serve two-year terms, which are staggered so that approximately half the elected seats become vacant each year. Elected members of PIC can be re-elected."

Because of the required staggering of terms, approximately half of the members to be elected will serve a two-year term (2012-2014), with the remaining members to be elected will serve a one-year term (2012-2013). Members are eligible for re-election.

At the February 2012 MAUT-LS general meeting, the membership concurred that we would continue using in the future the email nomination process which was first used in the fall of 2011 to fill a vacancy on the Executive.

Interested candidates and potential nominators for the PIC vacancies now being filled should therefore proceed by sending the following emails to the following people:

- The first nominator should email one or more members of the MAUT-LS Nominating Committee, nominating a candidate to be a member of PIC. This email can (and preferably should) be copied to the second nominator and the candidate.
- The second nominator should likewise email the MAUT-LS Nominating Committee to nominate the candidate. This email can (and preferably should) be copied to the first nominator and the candidate.
- After the two nominations have been sent, the candidate should email the MAUT-LS Nominating Committee to state that he or she accepts the nomination and agrees to serve if elected or acclaimed.

Any current member of MAUT-LS is eligible to make a nomination and/or to be a candidate for the position.

The period for nominations will run from August 20, 2012 until 5 p.m. on Friday, September 14, 2012.

Once the nominations are received an electronic ballot will be prepared. The number of votes each candidate receives will determine the positions that will be filled on the committee. Two year terms will first be filled by the three nominations with the most votes, and then single year terms will be filled by the remainder of the candidates in rank order by number of votes. For any tie votes, the Nominating Committee will arrange for a straw vote.
