Fédération Québécoise des Professeures et Professeurs d'Université (FQPPU)

The FQPPU held its 87th and 88th *Conseil Fédéral* on April 21-22 and October 20-12, 2016, respectively. Some highlights:

- Creation of a *Comité sur la gestion des universités*. Bernard Robaire will serve as MAUT representative on this committee.
- The following workshops are planned for the coming year: *Le droit de gérance*, *Les mesures disciplinaires universitaires*. MAUT members are invited to attend.
- The FQPPU launched a campaign asking the Québec government to provide new funding for a \$10,000 annual research grant to all tenure-track professors at Quebec's universities, in an effort to reduce inequalities between universities and disciplines in access to research funding.
- The FQPPU submitted a report to the Quebec government with its recommendations for the planned *Conseil des universités du Québec*, demanding that the *Conseil* be an independent body with the resources to do independent research and be devoted to, among other things, "the development of the university network in order to put an end to competition between universities" and "accessibility to post-secondary education, institutional autonomy, academic freedom, collegial management, collaboration between institutions, and the conception of universities as a public service."
- Our own Bernard Robaire was the co-recipient of the FQPPU's 2016 Guy-Rocher Prize in recognition of his exceptional contributions to the development of Quebec's institutions of higher learning and the promotion of equity, democratization, collegiality, and academic freedom.

The FQPPU is calling for candidates for election to its executive committee.
