Discussion: Committee of the Whole (15 minutes)

- **606.1** Associate Dean Burns took over the Chair of the Committee of the Whole at 3:20 p.m.
- **606.2** Associate Dean Burns gave a history of tenure.
- **606.3** Associate Dean Burns said that tenure at McGill requires superior performance in two of three areas (research, teaching and administration) and reasonable performance in the third.
- **606.4** Associate Dean Burns posed three questions to stimulate the discussion;
 - 1. Should there be tenure?
 - 2. Should tenure be reviewed at a later date?

3. What is superior performance, and should superior performance in two, rather than three, categories be enough?

- **606.5** Associate Dean Burns noted that many universities across North America were examining whether to have tenure. A member gave an example of the importance of tenure in enabling free speech and resisting political pressure.
- **606.6** It was suggested that the most important of the three categories be identified. However, a member emphasized that superior performance was required in two of the categories, and a reasonable performance in the third; candidates could not be inferior in any category. In response to a suggestion that administration be discounted for purposes of awarding tenure, a member emphasized the importance of administration to the functioning of a unit. It was pointed out that there was a perception among students that research was considered more important than teaching.
- 606.7 A member mentioned that a MAUT workshop on tenure and mentoring was scheduled for March 2, 2006 at 12:00 noon.

- 606.8 A member requested that at a future meeting, information be provided concerning tenure rates in the Faculty of Science in comparison to other faculties, and at McGill in comparison to other universities in Canada and the USA.
- 606.9 Associate Dean Burns said that members should feel free to send any further comments along to him.
- **606.10** Dean Grant resumed the chair of the meeting at 3:35 p.m.
- **606.11** Dean Grant commented that it was important that a candidate's file demonstrate superiority in all three categories.

- Senate Meeting of November 16, 2005 - Prof. N. Kamran

The highlights of the Senate Meeting of November 16 were the following:

1) Waiting lists and course selection on Minerva:

In response to a question from Senator Krajewska about the absence of online waiting lists for capped courses, Professor Masi (Interim Provost at the time), responded that the Registrar's office is working on a pilot project that would use wait list features that come with the Minerva system. The pilot project is implemented in the Faculty of Law for now, but it is expected that it will be extended to other Faculties once a number of procedural issues are resolved.

2) Services for individuals with disabilities:

In response to a question from Senator Stubley on the University's commitment to apply the "McGill Standards for a Barrier Free Campus" for construction and renovation projects, Professor Yalovsky (Vice-Principal Administration and Finance) noted that while the downtown campus is 85% accessible, full accessibility remains the goal. He noted that student-related accessibility is a priority in selecting projects for improved access. However most of the remaining inaccessible space is associated with 19th century legacy buildings, where the costs to provide accessibility are extensive in relation to the amount of space made accessible and in most cases the functions which occur in these inaccessible spaces can be relocated to other areas.

3) Planning White Paper on the future of the University:

Professor Masi gave a detailed presentation of the draft Planning White Paper, which presented an exciting vision for the future of the University. The document emphasizes the need to maintain the core disciplines and core faculties, while advancing transdisciplinary research and teaching. The need for systematic benchmarking was stressed repeatedly. Professor Masi also explained that increases in enrolment would only be entertained in targeted areas in which growth could be foreseen. The next draft of the Planning White Paper will be presented to Senate after the New Year.

- Senate Meeting of December 7, 2005 - Prof. C. Lin

Prof. Galaty made a motion of thanks to Prof. Sam Noumoff, who was attending his final Senate meeting. Sam has served as a Senator since 1976.

Most of the meeting was taken up by the Master Plan. An overview of the Plan was presented by consultant Mr. Jack Diamond. He noted the Plan needs to be sufficiently

flexible to respond to changes and planning initiatives. The timing for the Plan is good, as McGill is in the midst of preparing an academic strategic plan or "white paper". Mr. Diamond noted north-south access is better developed in the downtown campus than east-west access, and more green space and bicycle paths would be desirable. The downtown campus also lacks space for students to gather and study outside of classrooms. The Plan is available on the McGill web site.

Senate passed the Policy on Harassment, Sexual Harassment and Discrimination Prohibited by Law, Report of the Nominating Committee, Regulations Regulating Leaves of Absence for Political Purposes, APPC Report and an Amendment to the Regulations Relating to the Employment of Academic Staff and Librarians.

- Senate Meeting of February 1, 2006 - Prof. M. Sutton

Items are annotated by their labeling in the Agenda.

I.I. Chair reported on her trip to India with the Quebec delegation. This should lead to new interactions between McGill and Indian universities.

She discussed the issues of complementarity between hospitals in Montreal. In particular meetings with the people involved are underway.

She reported on her trip to Ottawa where McGill met with various government officials.

II.A. Questions and Motions by Members

II.A-1 Question re: What is McGill's policy on spousal hire? (by Prof. GowriSankaran) Provost Masi, reported on what was currently being done by the university. This includes financial incentives to departments of McGill for hiring the spouse and consultants to help the spouse find work in Montreal, as appropriate. Great care is taken to avoid conflict of interests. This active involvement by McGill seems to be working well and helpful for hiring new faculty.

II.A-2 A second question (by Mr. Reed): What is the current status and policy on text matching software? Provost Masi reported that negotiations with Turnitin.com are underway and hopeful a contract will be decided soon. Part of the delay is that in order to satisfy McGill policy, changes in the current software needed to be agreed upon and made.

II.A-3 A third question (by Ms. Krajewsak): The question was about whether a booking of a room at McGill by the Prime Minister was held up by "bureaucratic red tape?" VP Yalovsky fielded the question explaining that a room was booked, but it was decided, because of a change in venue, that it did not meet the requirements of the proposed meeting and so the Liberal Party moved the meeting to a more appropriate venue at Concordia. As well, he mentioned that there should be a web-based room booking system in place.

II.B. Motions and Reports from Organs of University Government

II.B-1 A report from the Senate Nominating Committee was received.

II.B-2 The annual report from the Committee on Student Discipline was received. A question about the possibility of separating the numbers between undergraduate and graduate students was asked. This will be looked into but a problem arises in keeping anonymity when reporting statistics on such small numbers.

The meeting was adjourned.

Dean Grant thanked the Senators for the Reports.
