Appendix A - Report of the Joint Board-Senate Meeting of October 25,

2010

Report of the Joint Board-Senate Meeting of October 25, 2010

The Chancellor welcomed Senators, members of the Board of Governors, and Governors Emeriti to the meeting, noting the importance of fostering awareness, creating exchanges, and broader understandings of the University and its mission, research, and service to the community. The Provost introduced the meeting's topic of *Strategic Initiatives in Graduate and Postdoctoral Studies in the Context of Academic Planning and White Paper* and its presenter, the Associate Provost (Graduate Education) and Dean of Graduate and Postdoctoral Studies, Professor Martin Kreiswirth.

The Associate Provost (Graduate Education) and Dean of Graduate and Postdoctoral Studies spoke about the importance of ensuring that McGill is the leading institution for graduate education in Canada, noting three challenges to that goal:

- 1) Generating sufficient student support funding to attract, retain, and graduate on time, the best graduate students and postdoctoral scholars, from around the world and around the corner.
- 2) Enhancing diversity and excellence in the composition of graduate student enrolment in programs across the University.
- 3) Improving the overall graduate student and postdoctoral experience, including training for the labour market.

Each of the tables of attendees discussed the challenges and subsequently presented their suggestions, which were recorded and presented at the meeting under the following headings for further discussion and consideration:

- 1) Corporate investment in professional personnel.
- 2) Develop pipelines for undergraduate target schools.
- 3) Innovative program delivery, experiential learning in context.

The Principal provided closing remarks, noting that the diverse background of attendees helped in generating varied responses. She indicated that the discussion highlighted the need for better graduate funding and support, but also remarked that the focus, this year, on graduate education does not diminish the position of undergraduate studies at McGill.
