

The following report is presented to Senate for information.

I. APPOINTMENTS

1. Appointment of Interim Principal [GD21-81]

The Board of Governors, on the recommendation of the Chair of the Board of Governors, approved the appointment of Professor Christopher Manfredi as Interim Principal and Vice-Chancellor for a term from September 6, 2022, until the next Principal is able to commence his or her term.

2. Members-at-large of the Board of Governors [GD21-73]

The Board of Governors on the recommendation of the Nominating, Governance and Ethics Committee approved:

- the appointment of Ms. Diletta Prando as a member-at-large of the Board of Governors of McGill University, for a four-year term commencing July 1, 2022 and ending June 30, 2026. Ms. Pando currently serves as member of the Human Resources Committee and the Equity, Diversity and Inclusion Committee of the McGill University Board of Governors.
- the appointment of Mr. Gregory David as a member-at-large of the Board of Governors of McGill University, for a four-year term commencing July 1, 2022 and ending June 30, 2026. Mr. David currently serves on the Finance Committee of the McGill Board of Governors.

3. Vice-Chair of the Board of Governors [GD21-73]

The Board of Governors, on the recommendation of the Nominating, Governance and Ethics Committee, approved the appointment of Mr. Pierre Matuszewski as Vice-Chair of the Board of Governors of McGill University for a two-year term commencing July 1, 2022 and ending June 30, 2024.

Mr. Matuszewski was appointed as a member-at-large in July 2017. He has also been a member of the Board's Finance Committee since October 2015 and its Chair since July 2017. Mr. Matuszewski is also a member of the Executive Committee since 2017.

4. Appointments to the Rank of Emeritus/a [GD21-78]

4.1 Appointment of Chair Emeritus

In recognition of his contributions as member and as Chair of the Board of Governors, the Board of Governors, on the recommendation of the Nominating, Governance and Ethics Committee, approved the appointment of Mr. Ram Panda to the rank of Chair Emeritus commencing July 1, 2022.

Mr. Ram Panda was appointed as Board Chair for a five-year mandate beginning on July 1, 2017 and has been serving as a member-at-large since 2014. His term as Chair of Board of Governors ended on June 30, 2022. His term as member-at-large on the Board ends on June 30, 2024.

4.2 Appointment to the Rank of Principal Emerita and Governor Emerita

In recognition of her outstanding contributions as academic head and executive leader and as a member of the Board of Governors, the Board of Governors, on the recommendation of the Nominating, Governance and Ethics Committee, approved the appointment of Professor Suzanne Fortier to the rank of Principal Emerita and Governor Emerita commencing September 1, 2022.

5. Appointment Trenholme Dean of Libraries [GD21-80]

The Board of Governors, on the recommendation of the Principal and pursuant to the advice of an Advisory Committee, approved the appointment of Dr. Guylaine Beaudry as the Trenholme Dean of Libraries of McGill University for a five-year term, renewable, commencing September 1, 2022 and ending on August 31, 2027. The Board, in accordance with the *Regulations Relating to the Employment of Librarian Staff*, also approved the appointment of Dr. Guylaine Beaudry to the rank of Full Librarian with tenure, effective September 1, 2022.

Dr. Beaudry holds a PhD in the History of the Book from the École pratique des hautes études (Paris) and a Master of Library and Information Science from the Université de Montréal. In October 2009, Dr. Beaudry joined Concordia University as Director of the Webster Library and served as interim University Librarian from July 2013 to April 2014. She was first appointed to the position of University Librarian by Concordia's Board of

Governors on May 1, 2014. Her second five-year term began on July 1, 2019. From 2017 to 2021, she was also Vice-Provost of Digital Strategy.

Prior to this, Dr. Beaudry was the Director of the Digital Publishing Centre at the Université de Montréal and Executive Director of Érudit, a publishing platform for scholarly books and journals in the social sciences and humanities. From 2008 to 2010, she served as President of the Corporation of Professional Librarians of Quebec and was a member of the Royal Society of Canada Expert Panel on the status and future of libraries in Canada.

II. OTHER APPROVALS

1. Policies

1.1 Policy on Assessment of Student Learning [GD21-77]

The Board of Governors, on the recommendation of Senate, approve the proposed [Policy on Assessment of Student Learning](#).

The updated Policy on Assessment of Student Learning (PASL) is principles-based, and less procedural than the USAP, while recognizing the importance of assessment for learning. It emphasizes the importance of feedback, accountability, equity, and is less exam-centric, with a broader understanding of modes of assessment.

1.2 Policy on the Study and Care of Animals [GD22-02]

The Board of Governors, on the recommendation of Senate, approve the proposed [Policy on the Study and Care of Animals](#).

In light of an assessment visit that will be conducted by the Canadian Council on Animal Care (CCAC) in Fall 2022 and given that the Policy on the Study and Care of Animals has not undergone any in-depth review since its inception in 2011, the Office of the Vice-Principal (Research and Innovation) has undertaken a two-phase review process of the Policy, which was approved by Senate. Phase 1 of the process has led to several administrative revisions, and Phase 2 will consist of a deeper review and subsequent updating of the Policy and will follow the University's consultation and approval processes.

1.3 Revised Policy against Sexual Violence [GD22-14]

The Board of Governors, on the recommendation of Senate, approved the proposed revisions to the [Policy against Sexual Violence](#).

The Board of Governors reviewed a recommendation to approve revisions to the Policy against Sexual Violence. McGill's Policy against Sexual Violence (PSV) was last reviewed in 2019. The most recent triennial review was carried out during the Winter and Summer 2022 terms, resulting in several proposed revisions, including the creation of the Office for Mediation and Reporting (OMR) as well as adjustments to our processes for

investigations of reports of sexual violence, drawing on experience over the last three years, and feedback from members of the working group struck to review the Policy.

2. CFI Grant Agreements

2.1 Grant Application to CFI Innovation Fund 2023 [ED21-53]

The Executive Committee of the Board of Governors, on the recommendation of the Vice-Principal (Research and Innovation), approved the submission of a grant application in support of the proposal entitled “McGill Translational Platform in Autism Research (MTPAR)” to the Canada Foundation for Innovation 2023 Innovation Fund.

The CFI proposal aims to advance understanding of underlying neuropathological mechanisms and to develop biomarkers for the early diagnosis and assessment of treatment approaches of Autism Spectrum Disorders (ASDs). The location of the infrastructure related to this project will be at the Neuro on McGill Downtown Campus and the MUHC-RI Montreal General Hospital.

2.2 Applications and Notices of Award to the Federal Research Support Fund and Incremental Projects Grant Program [ED21-54]

The Executive Committee of the Board of Governors, on the recommendation of the Vice-Principal (Research and Innovation), approved applications and notices of award for the Research Support Fund (RSF) program and its Incremental Projects Grant (IPG) stream, administered by the Tri-agency Institutional Programs Secretariat (TIPS), and authorized the Vice-Principal (Research and Innovation) to submit applications and approve notices of award for the period from, 2022 to 2027.

The RSF and IPG are annual grants that provide support with regard to the indirect costs of managing research funded by the three federal research granting agencies: the Canadian Institutes of Health Research (CIHR); the Natural Sciences and Engineering Research Council (NSERC); and the Social Sciences and Humanities Research Council (SSHRC). Grants are awarded for one year only. Institutions must re-apply every year and meet all terms and conditions of funding in order to continue receiving these funds. The Board of Governors previously approved applications and notices of award for the RSF and IPG program in May 2018 and June 2019.

3. Amendment to the Public Health Agency of Canada Agreement for the Canadian Consortium for Covid Assessment of Immunity [GD22-02]

The Board of Governors, on the recommendation of the Vice-Principal (Research and Innovation), retroactively approved an amendment to the Agreement between McGill University and Her Majesty the Queen in Right of Canada, represented by Public Health Agency of Canada (PHAC), signed on June 17, 2020.

4. Recommendation concerning Naming Proposal for University Asset [GD22-03]

The Board of Governors, on the recommendation of the Interim Principal and Vice-Chancellor, and pursuant to the advice of an ad hoc committee established under the Policy Relating to the Naming of University Assets, approved one naming proposal concerning a University asset. The naming of the asset will be announced publicly in due course.

5. Resolution approving commitments of the Board of Governors under sections 5.8 and 5.11 of the Règles budgétaires et calcul des subventions de fonctionnement aux universités du Québec [ED21-45]

The Executive Committee, on the recommendation of the Vice-Principal (Administration and Finance), approved the resolution prepared by the Ministère de l'Enseignement supérieur (MES), confirming the Board of Governor's commitment the *Règles budgétaires et calcul des subventions de fonctionnement aux universités du Québec*. The Règles present the budgetary rules and methods for calculating the operating grant allocated to university educational institutions.

6. Computer Equipment Contracts [ED21-46]

The Executive Committee of the Board of Governors, on the recommendation of the Vice-Principal (Administration and Finance) approved the proposed contracts with D&H Canada ULC, Dell Canada, Elco Systems Inc., Insight Canada Ltee, Royal Photo Inc., Synnex Canada Inc., and Xerox Canada Ltee. for the supply of Computer Equipment for resale by Le James Bookstore to the McGill community with a term of 36 months.

7. 2022-2023 Borrowing Resolution from *Financement-Québec* [ED22-05]

The Executive Committee of the Board approved a standard borrowing resolution received from *Financement-Québec* for 2022-2023.

Consistent with prior years, *Financement-Québec* asked the University to institute a *régime d'emprunts* to borrow from *Financement-Québec* as a way to receive the next installment of the Quebec capital grant. This maximum borrowing amount for McGill for the 12-month period ending June 30, 2023 is \$26,533,300, based on confirmation from the *Ministère de l'Enseignement supérieur* (MES).

8. Report of the Audit and Risk Committee [ED21-48]

8.1 Delegation pursuant to the Directive concerning Risk Management in Contracting Processes

The Executive Committee, on the recommendation of the Audit and Risk Committee, approved, to delegate to the Vice-Principal (Administration and Finance) the functions, responsibilities and authorities conferred on the University's chief executive officer by the *Directive concernant la gestion des risques en matière de corruption et de collusion dans les processus de gestion contractuelle* ("Directive"), as amended from time to time,

including the authority to approve annual risk management plans, monitoring reports and any associated documents related to the Directive.

8.2 Declaration of Compliance to Quebec Treasury Board

The Executive Committee, on the recommendation of the Audit and Risk Committee, authorized the Vice-Principal (Administration and Finance) to sign Annex 3 of the *Directive concernant la reddition de comptes en gestion contractuelle des organismes publics* and any related documents, on behalf of the Board of Governors.

The Executive Committee of the Board of Governors, on the recommendation of the Audit and Risk Committee, also approved the submission of a declaration of compliance to the Quebec Treasury Board in the form of Annex 3 of the *Directive concernant la reddition de comptes en gestion contractuelle des organismes publics*.

9. Report of the Building and Property Committee [GD21-74]

9.1 2001 McGill College Medicine and Science Laboratories (Lot 1 of 2)

The Board of Governors, on the recommendation of the Building and Property Committee, approved Lot 1 of a project involving the relocation of the Centre for Research on Brain, Language and Music (CRBLM), a strategic research group with a unique interdisciplinary focus on language, music and their intersection, to Medicine and Science Laboratories at 2001 McGill College.

The CRBLM is currently housed in the Rabinovitch House, a property that is in poor condition and currently listed in the McGill University Master Plan for disposition.

10. Report of the Committee to Advise on Matters of Social Responsibility [ED22-06]

10.1 Procedures for Reviewing Expressions of Concern

The Executive Committee was informed that CAMSR approved, in final form, the Procedures for Reviewing Expressions of Concern. The Committee had approved the draft Procedures in principle at its meeting of March 17, 2022, subject to the incorporation of revisions suggested by members at the meeting. A duly revised draft of the Procedures was submitted to the Committee and approved via e-vote on June 13th, 2022. The Procedures provide a framework to assist the Committee in its work on reviewing expressions of concern.

11. Report of the Nominating, Governance, and Ethics Committee [GD21-78, ED21-42]

11.1 Revisions to Board Committee Terms of Reference

The Executive Committee and the Board of Governors, on the recommendation of the Nominating, Governance and Ethics Committee approved the proposed revisions to the

[Nominating, Governance and Ethics Committee’s Terms of Reference](#), [Building and Property’s Committee’s Terms of Reference](#), [CAMSR Terms of Reference](#), [Sustainability Committee](#) and the [IT Committee Terms of Reference](#) which establish for members appointed from within the McGill staff and student community, eligible pools of members who would be considered for appointment to Board committees. This change would align the model for the staff and student community with the one in place for members-at-large, alumni representatives and Governors Emeriti.

12. Report of the Investment Committee [ED21-50]

12.1 Annual Distribution Rate for Endowment Income FY2024

The Executive Committee of the Board of Governors, on the recommendation of the Investment Committee, approved, for the fiscal year ending April 30, 2024, an income distribution rate of 4.0% applied to the four-year rolling average of the McGill Investment Pool market value determined at April 30, 2019, April 30, 2020, April 30, 2021 and April 30, 2022.

13. Report of the Finance Committee and Building and Property Committee [GD22-04]

The Board of Governors, on the recommendation of the Building and Property Committee and the Finance Committee, approved the construction phase of the New Vic project.

14. Revisions to the Terms of Reference of the Executive Committee further to the amendments of the University Statutes [ED21-40]

The Executive Committee of the Board of Governors approved the proposed revisions to the [Executive Committee’s Terms of Reference](#).

III. INFORMATIONAL ITEMS

1. Report of the Audit and Risk Committee [GD22-18]

1.1 Financial Report to the Board of Governors 2021-2022, Audited Financial Statements and Auditor’s Report

The Board of Governors, on the recommendation of the Audit and Risk Committee, approved the 2021-2022 Financial Report to the Board of Governors including the external auditor’s report and Audited Financial Statements of The Royal Institution for the Advancement of Learning/McGill University for the year ended April 30, 2022.

1.2 Appointment of External Auditors for Fiscal Year 2023

The Board of Governors, on the recommendation of the Audit and Risk Committee, approved the appointment of Deloitte as external auditors of the University for the fiscal year ending April 30, 2023.

2. Report of the Building and Property Committee [GD22-16]

2.1 Design of Project: Parasitology Institute at Macdonald Campus

The Building and Property Committee, on the recommendation of the Vice-Principal (Administration and Finance), approved to complete the design phase with a budget of \$1,390,144, and proceed to tender for the project at the Parasitology Building at Macdonald Campus –Deferred Maintenance Work. The project will be funded by the Ministère de l'Enseignement supérieur (MES) in the form of capital allocations for deferred maintenance projects.

Tender for construction is planned for early 2023. Construction will begin in Fall 2023 with an anticipated completion in the Fall of 2026.

2.2 Construction of Sports Science Institute Project

The Committee considered a recommendation for the Board of Governors to approve the Sylvan Adams Sports Science Institute (SASSI) project which comprises the redevelopment of the Pine Avenue row houses site. Noting that the tenders for the project were higher in cost than expected, the Committee, taking into account the generally high cost of construction in the current market, asked the administration to carry out a process of further due diligence. The Committee will receive an update on this file at a later meeting.

2.3 Update on the Special Funding Program for Upgrades to Sports and Leisure Facilities

The Committee received an update on projects submitted for funding consideration under the *Ministère de l'Éducation's Programme de soutien aux infrastructures sportives et récréatives scolaires et d'enseignement supérieur* ("Programme").

In December 2021, the Committee approved to adopt three standard resolutions required in order to submit projects for funding to the programme relating to the renovation and upgrades of the Glenfinnan Arena, the McConnell Arena and the tennis court at Macdonald Campus. As an update, the Committee was informed that funding was approved for the deferred maintenance work at McConnell Arena and for the repurposing of the Tennis Courts at Macdonald Campus, but not for the deferred maintenance work at Glenfinnan Arena.

The University does not foresee that it will be required to shut down the arenas or stop making them accessible to the general public.

3. Report of the Committee to Advise on Matters of Social Responsibility [GD22-09]

3.1 Update on McGill Investment Pool Responsible Investment Practices

The Committee received, for information, an update on the action plan to reduce the carbon footprint of the McGill Investment Pool. The Committee was informed that, in

addition to the implementation of the University's eight Responsible Investing commitments, the Office of Investments continues to further develop McGill's responsible investing practice, in line with these commitments, particularly in the areas of Institutional Leadership and ESG Integration & Engagement. For example, it was reported that the University is now a signatory of the Principles for Responsible Investment, a United Nations-supported international network, and the world's leading proponent of responsible investment. The Committee will receive, at its next meeting, the annual SRI report that will further track the University's realization of the commitments in the area of SRI established by the Board in December 2019.
